

LOBOS PLAYER / PARENT COMMITMENT LETTER

A player selected to become a member of the **LOBOS** will be asked to sign a **LOBOS** Player Commitment Letter. As this letter indicates, it is important that, before your player accepts our invitation, everyone understands that there are obligations that come with becoming a member of a competitive soccer team. At this level of competition, success and fun on the soccer field do not come without some extra effort.

We ask **LOBOS** parents to assist in helping this player understand the nature of the commitment he/she is making as well as the parents' commitment. Please review the Commitment Letter with your player. Before your player can be accepted on a **LOBOS** team, we must have a copy of the following Commitment Letter signed by the player and one parent.

AGREEMENT

As a **LOBOS** player, I understand that being extra-ordinary takes extra effort. I understand that wanting to win on the day of the game is worth nothing unless I have the will to prepare to win before the day of the game. So that I might be the best player and team member that I am capable of becoming, I promise to do the following:

1. I promise to arrange my schedule so that I can regularly be at practices, scheduled team meetings, scheduled games and tournaments on time. No fees will be waived or returned due to me not attending any program or event.
2. I promise to work hard at practice to improve my soccer skills and my understanding of the game. I understand the amount of playing time I receive in games will be based on my skills, determination in practice, punctuality, and attitude. I understand that I may receive more or less playing time per game than my team members. I acknowledge that the coaches have final decision on the level of play, leagues, tournaments, and friendly travel. I promise that I will give the coaches my full attention.
3. I promise to encourage, never criticize, and be supportive of my teammates and all other **LOBOS** teams. I promise to be a positive role model in all areas of behavior. No Drugs, No Alcohol, No Smoking, No Abusive Language, No Destructive Behavior. I understand that violation of this policy may be the basis for suspension or dismissal from the team.
4. As a **LOBOS** parent, I acknowledge that I have read the payment policy & understand that club fees are due upon my player accepting a place on the above team. If all fees (club & team) are not paid in a timely manner, I realize my child's participation can be restricted & the player card can be held until these fees are paid & are up to date. I understand that I am committing my player to attend all the team activities and events and that I am responsible for my part of the fees required to participate in these leagues, activities and events even if he/she does not attend.
5. As a **LOBOS** parent, I acknowledge that any damage caused by my player, any member of my family or any friends attending any event, activity or practice, under any circumstance, will be my responsibility and that I am liable to make restitution in a timely manner. I acknowledge that if I do not make restitution that my player will not be allowed to play until such payments and problems are cleared up. I also acknowledge that if a discipline infraction occurs, my player may be asked to give up his/her place on the team. I understand that CSA has a Discipline Committee under which my player may be sanctioned due to inappropriate actions.
6. As a **LOBOS** parent, I understand that I am to work a club fundraising event held during the seasonal year. I acknowledge these events are held in order to reduce the club fee and offset operating costs. I understand that if I do not work the fundraising event, I will be assessed an additional fee.
7. Collierville **LOBOS** club fees are non-refundable. If the player chooses to leave the club at any time, no portion of the fee is guaranteed to be refundable. If injured in such a manner that the player is unable to participate for the remainder of the seasonal year, CSA will make a determination if any portion of the fees is refundable. If the player moves beyond a reasonable travel distance before the end of the seasonal year, CSA will make a determination if any portion of the fees is refundable.
